BOARD OF DIRECTORS RESOLUTION
PG-3.201 ADMISSIONS AND ENROLLMENT**

Date of Meeting and Resolution: April 23, 2026

Requested Amendment Effective Date: April 23, 2026

WHEREAS, the Board of Directors of UT Tyler University Academy convened a duly posted public meeting on April 23, 2026, in full compliance with the Texas Open Meetings Act, Texas Government Code Chapter 551, with a quorum present as reflected in the official minutes;

WHEREAS, the Board is authorized to adopt and amend policies governing admissions and enrollment;


WHEREAS, the Board reviewed proposed amendments to Policy PG-3.201 (Admissions and Enrollment);

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Directors of UT Tyler University Academy hereby approves the amended Policy PG-3.201 – Admissions and Enrollment effective April 23, 2026, including the following updates:


1. Updated Policy Number and Codes
 - a. The policy reflects the updated policy number PG-3.201 and revised internal administrative codes as applicable.
2. General Eligibility for Admissions
 - a. Included information on where individuals apply and that applicants shall complete the application form for the specific campus for which they seek enrollment.
 - b. Student applications will open on January 10th of each academic year (revised from February).
 - c. The admissions lottery will be conducted on the first Friday upon which classes are held in April.
 - d. Information specifying a fixed geographic boundary was removed and replaced with language identifying students who reside within commuting distance of a campus operated by UT Tyler University Academy for the grade level for which enrollment is sought. Additionally, the conditions for admittance were reviewed and consolidated to improve clarity, consistency, and ease of implementation.
3. Waitlist Reporting Requirements

- a. The policy includes updated language reflecting the Academy’s obligations regarding waitlist maintenance and reporting, consistent with applicable Texas Education Agency requirements.
- 4. Students with a Documented History of Criminal Offense or Misconduct
 - a. The policy is revised to state that the Academy may exclude from enrollment a student who:
 - i. Has engaged in conduct outlined in Texas Education Code §37.006 related to placement in a Disciplinary Alternative Education Program (DAEP) or a Juvenile Justice Alternative Education Program (JJAEP);
 - ii. Has engaged in conduct outlined in Texas Education Code §37.007 related to expulsion; or
 - iii. Has been convicted of a criminal offense or has a juvenile court adjudication, as authorized by Texas Education Code §12.111(a)(5)(A).
 - b. This revision replaces prior, broader language that allowed exclusion based generally on a history of criminal offense, juvenile court adjudication, or other disciplinary problems under Chapter 37.
- 5. Immunization Requirement Exception for Armed Forces Members
 - a. The policy is updated to clarify that immunizations are not required for students who can provide documentation verifying membership in the armed forces, in accordance with applicable law.
- 6. Student Residency Documentation
 - a. The policy updates the types of documentation the Academy may accept to verify student residency when the student resides separately from a parent or guardian.

BE IT FURTHER RESOLVED THAT the Board of Directors adopted the amended Policy PG-3.201 (Admissions and Enrollment) on April 23, 2026, as reflected in the duly posted meeting agenda and the official minutes of the meeting. This Board Resolution, executed by Board members in attendance, serves to formally confirm and document the Board’s approval and adoption of the policy.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, The University of Texas at Tyler (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

To let us know of a change in your email address where we should send notices and disclosures electronically to you, you must send an email message to us at Systems_Analysts@uttyler.edu and in the body of such request you must state: your previous email address, your new email address. We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from The University of Texas at Tyler

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to Systems_Analysts@uttyler.edu and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with The University of Texas at Tyler

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to Systems_Analysts@uttyler.edu and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software

Acknowledging your access and consent to receive and sign documents electronically
